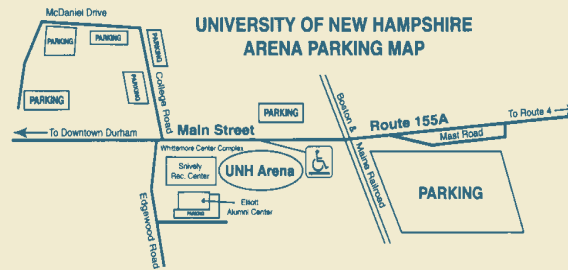

### Directions to the University of New Hampshire Arena:

**From Boston:** I-95 North to Exit 4 (NH Lakes and Mountains, Spaulding Turnpike). Continue to Exit 6W and follow Route 4 west past UNH/Durham Route 108 Exit. Exit at Route 155A and turn east toward Durham. Follow 155A through a short stretch of fields to UNH campus. Use map for Arena parking locations.

**From Portland:** I-95 South to Exit 5. Continue on Spaulding Turnpike to Exit 6W and follow Route 4 West past UNH/Durham Route 108 Exit. Exit at Route 155A and turn east toward Durham. Follow 155A through a short stretch of fields to UNH campus. Use map for Arena parking locations.

**From Concord:** Route 4 East to the Route 155A Exit. Follow 155A through a short stretch of fields to UNH campus. Use map for Arena parking locations.

**From Manchester:** Route 101 East to Epping and exit onto Route 125 North. Continue to the Lee Traffic Circle and take Route 4 East to the Route 155A Exit. Follow 155A through a short stretch of fields to UNH campus. Use map for Arena parking locations.

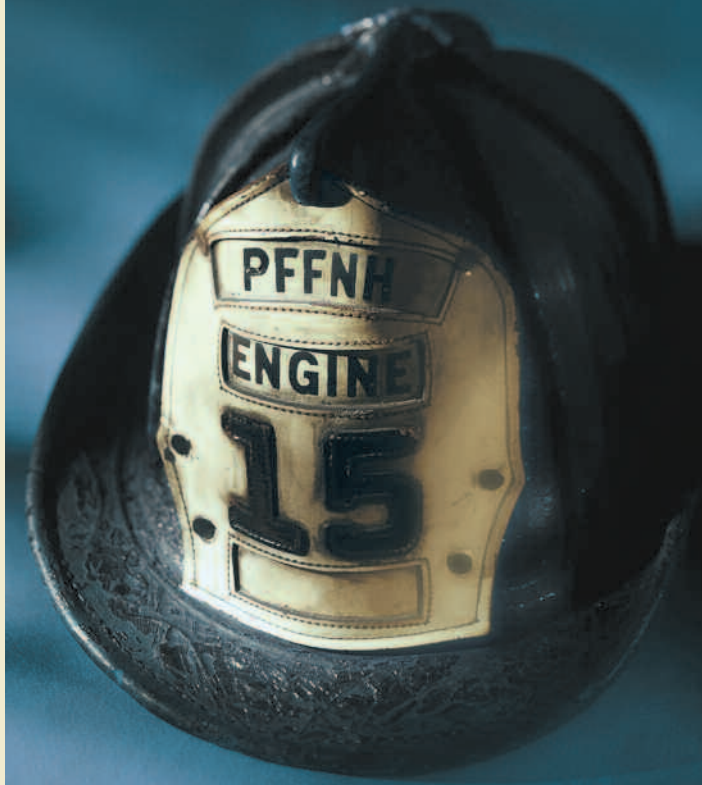

The Professional Fire Fighters of New Hampshire is proud to announce that, because of your generous support, eleven grants have been awarded to local fire departments to use in the purchase of non invasive Pulse CO Oximeters. These state of the art devices will help save the lives of firefighters and the public as well. This device reads the amount of oxygen and carbon monoxide found in the blood stream.

This program is important to the safety of firefighters coming out of burning buildings, and to a greater extent an invaluable tool for residents of this state who are alerted through household detectors that Carbon Monoxide is present in their home, or are experiencing possible symptoms of carbon monoxide poisoning.

The diagnosis and treatment times relating to carbon monoxide poisoning are crucial to the extent of the damage caused to the body.

- Prevented insurance companies from preauthorizing emergency ambulance service. Signed into law May 2000.
- Promoting stronger laws on behalf of firefighters to help prevent injury.
